"Envisioning Moving Frontiers: Migration Management, Minority Protection and the Enhancement of Territorial Cooperation"

Framework, Rationale and Purposes

Established in 1995 with the aim of creating an arena for dialogue and cooperation for youngsters from the Yugoslav successor states in war, the School has become a CEI recurrent event since then. With a strong international dimension, thanks to the active involvement of IECOB Institute for Centraland Balkan Eastern Europe, the EBIN Europe and the Balkans International Network (established in 1992 with a financial contribution of the EU), the CEI International Summer School has been attended by MA students, NGO activists, and vouna professionals not only from the Balkans, but from all CEI countries. In the last 20 years, the School has offered year by year from 1 to 3 courses on the following topics: diversity management, post-communist transition challenges, economic and entrepreneurships, cultural tourism, agricultural and environmental problems.

With the 23rd edition of the School, IECOB and CEI aim to promote a one week international forum of experts and young professionals in human rights issues with the aim of stimulating a dynamic discussion on over the prospective developments related to the implementation of minority rights in our increasingly diversified societies; the of territorial principles integrity and territorial cooperation. Furthermore, the relationships between migrant and diaspora communities will be investigated as broad global phenomena, and discussed in the framework of both the existing nation-states and the EU integration processes, while elaborating on the CEI role in these contexts.

The Thematic Foci of the School

The 23rd CEI summer school will scrutinize the prospective developments related to a

twofold research focus: the implementation of Migration management and security issues, involving both the internal migration related to the war in Eastern Ukraine and the external migration faced by Western Balkans in the recent years, as well as the rise of new internal frontiers in Europe, conceived to face the escalating migration crisis.

The current situation can be considered an actual 'testing ground' for the European Union's commitment to human rights and open borders. Especially, it was the South East European area that faced the most serious challenges, following the rise of the Western Balkans migration route in 2015. The emerging obstacles in finding a collective and cross-border approach based on cooperation between the countries along the route reflected the difficulties in establishing a common strategy in EU in order to face the emergency situation.

Following this focus, the relationships between minority and majority groups in CEI member states will be investigated through the lenses of the recent 'encounter' between local and migrant communities. The making of 'inclusive' and 'exclusive' identities, in the aftermath of both the Ukraine Crisis and the Migration Crisis, will lie at the core of the research focus. On the one hand, the discussion will be focused on the political and dynamics the migration cultural of phenomena the Ukrainian involving Russophone community during the last years, in an attempt to understand the transformation of the complex dynamics of belongings following the 'shifting borders' between Western and Eastern Ukraine.

On the other side, the School will give space to discussion of political and cultural dynamics of drawing frontiers and polulation movements in the Balkans. The presentations will analyze processes of









boundary making, both in political and material, every-day, aspects of multiple negotiations of belonging, mostly in post-Yugoslav space ranging from Bosnia and Herzegovina to Macedonia, following the impact of the migration phenomena on the self-perception of local communities. These topics play a crucial role in strengthening a democratic development built on diversity management and respect /preserving of cultural diversities.

As a result, the 23rd CEI International Summer School has been designed to address and discuss the challenges faced by the European and Nation-State governance relation security in to issues, and sociopolitical developments in the area following the above-mentioned twofold perspective. Events concerning Hungary, Serbia, Croatia, Albania, Macedonia and Ukraine are some of the case-studies that will be analyzed. In addition, the school will focus on the new conceptualizations (such as cultural métissages, nomadism, interculturality, diversity management and deliberation), gender relations, and existing legal, social and cultural instruments for the protection of minorities in the broader sense.

Also, given the traditionally academic nature of the initiative, the CEI summer school 2017 will be complemented by a set of methodological seminars and workshops aimed at strengthening participants' ability in dealing with presentation and reporting of research results in academic writing and papers to be published in academic journals. The focus will be on the main aspects of academic writing style, referencing, argument-based writing, data display, and issues of plagiarism.

Moreover, the summer school teaching curriculum will include a soft skills building seminar aimed at the development of a multi-cultural mindset and at stimulating students' ability in cross-cultural communication and negotiation, as well as adaptability and flexibility in heterogeneous co-working contexts.

Finally, the last day of the week will be devoted to the international conference Restructuring Identities vs. Managing Minorities. Fostering Intercultural Dialogue and Preserving Cultural Diversity in Southeastern Europe, which will take place at the castle of Bertinoro, co organized by the University of Bologna – Department of Social and Political Sciences.
