Restructuring Identities vs. Managing Minorities. Fostering Intercultural Dialogue and Preserving Cultural Diversity in Southeastern and East-Central Europe.

International Conference September 15th 2017

It is without saying that the relationship between minority and majority groups plays a crucial role in strengthening a democratic development built on diversity management and respect/preserving of cultural diversities. Following these lines, on the one hand, national identity can be meant as pursued by nation-building elites by stressing the domestic similarities of the in-group in contrast to foreign 'others', while, on the other, nation-building cannot be interpreted only as the policies adopted at the national level, but also as the way minority and majority groups react to them.

In the aftermath of the recent crises, the CEI countries faced new emerging obstacles in finding collective approaches based on cooperation between the diverse members of the national cultural and social milieus – and here the recent political crisis in Macedonia is only one of the cases at stake.

The members of the Italian scientific committee based in Forlì Campus (Università di Bologna – Dipartimento di Scienze Politiche e Sociali – Centro per l'Europa Centro-Orientale e Balcanica – UOS di Forlì), in cooperation with the editorial board of "Southeastern Europe" Journal (Brill Publishers), aim to reflect on the issues at stake in the area, welcoming participants from the Balkan countries and Ukraine, and promoting academic cooperation.

As a result, the conference "Restructuring Identities vs. Managing Minorities. Fostering Dialogue Intercultural and Preserving Cultural Diversity in Southeastern Europe", which will take place in Bertinoro on September 15, 2017, will envision the identity and minority issues following both national and macro-regional perspectives, in an attempt to understand the transformation of the complex dynamics in drawing national (and all-European) borders from South-East and East-Central European perspectives in the light of the recent crisis that affected, in different ways, Ukraine, Macedonia, Kosovo, Bosnia-Herzegovina and the Albanian-Serbian relations, while the EU has often been powerless in convincing the local leaderships to make reforms and proceed toward the EU integration. In this frame, the making of 'inclusive' and 'exclusive' identities will lie at the core of the research focus of the conference.
